A. It is further agreed that AYC will not perform and is not responsible for any evaluation of participant's physical condition to which may help to identify risk factors contradicting to any physical exercise prior to his/her starting or continuing an exercise activity.

B. Participant hereby warrants, represents and agrees that he/she has no physical disability, impairment, or ailment preventing him/her from engaging in any exercise activity, or that will be detrimental to his/her health, safety, comfort or physical condition, or that of others. It is always advisable and AYC recommends the participant to consult his/her physician before undertaking a yoga exercise program if the participant considers necessary.

C. Participant hereby agrees to waive any and all claims or right he/she might otherwise have against AYC including but not limited to the right to sue AYC, its members, teachers, volunteers or agents, for any injuries or claims whatsoever.

D. Participant has carefully read this waiver and release and fully understands this is a full release of any and future claims against AYC for any injury or risk of injury resulting from activities whatsoever while attending or joining AYC programmes. Participant further agrees to fully release AYC from any liability for any loss or theft of personal property.

Personal Information Collection Statement

Purpose of Collection: The Andiappan Yoga Community (“AYC”) will collect your personal data to provide you with activities, programmes or services relevant to your needs, including but not limited to monitoring, review and development of yoga-related activities, programmes or services.

- c) Where such disclosure is authorized or required by law.

Access to Personal Data: Except where there is an exemption provided under the Personal Data (Privacy) Ordinance, you have a right of access to and correction of personal data or obtaining a copy of the data you provided. However, under normal circumstances, data will be erased after fulfilling the purposes of collection.
